For the Class of 2017, New Lima graduates are required to have a valid EOI score in four of the seven subjects assessed. (Score can be Advanced, Proficient, Limited Knowledge or Unsatisfactory). The WorkKeys assessment may be used as an alternate test to meet the four of seven requirements. Also, a valid ACT sub-score may be used to replace the EOI test in the corresponding area of study. By December 31, 2016, the Oklahoma State Board of Education will adopt a statewide system of student assessments to meet Every Student Succeeds Act (ESSA) requirements. This system will be used for the Class of 2018 and subsequent years.
